This is the privacy statement of P. Aker Zaden en Bloembollen BV. In this we describe how we handle your personal information collected by us. 1. Goal

The personal data obtained by us will be processed to provide services, to send offers and to ensure the full execution and compliance with agreements entered into with you. In addition, we will collect these data for sending commercial newsletters and newsletters that are aimed at sharing knowledge.

2. Legal basis

The collection, processing and use of your personal data is only permitted if we have a legal basis for this. This may consist of permission obtained from you, a legal basis, or that may result from the execution and/or compliance with an agreement made with you.

3. Personal data and storage period

The personal data we process are the minimum required data for offering our services and products and relate to the name of your company, the name of your contact person (s), your (email) address, your telephone number, as well as those data that are necessary for the execution and compliance with agreements made with you.

Your personal data will not be stored for longer than necessary, unless we have to keep your data for longer because of a statutory regulation.

4. Security

We handle your personal data carefully. To prevent unauthorized access, we have taken technical and organizational measures that ensure an appropriate level of security. In light of this, we have provided security for our website, our IT systems and the physical areas where personal data is stored, while only authorized personnel can view your personal data.

5. Provision to third parties

We will only disclose personal data to third parties if this results from the execution and compliance with agreements entered into with you, if you have explicitly granted permission for this or if the law obliges us to do so.

On our website you can find measuring instruments from other parties, such as cookies from Google Analytics. We do this to keep track of how visitors use our website. We use this knowledge to optimize our website for our visitors.
